

Rules for online abstract submission

Submission requirements

- By accessing and/or using the online submission system you agree (also on behalf of co-authors) to the rules as set out below.
- Only abstracts submitted through the official online submission system will be considered.
- Abstracts must be submitted in English. This applies also to the title, text body and author affiliations.
- Authors may submit more than one abstract but are asked to exercise reasonable restraint.
- All sources of financial support (including government grants or companies which handled the data) must be listed in the assigned answering box as part of the submission procedure (and not in the abstract text). All grant funding agencies and/or company abbreviations should be spelled out. This information will be published with the full body abstract, wherever it is reproduced on publications, channels or online.
- Please note that transfer of copyright applies to all material submitted through the online system.

Originality

Abstract(s) may not have been published before the start of the EMUC congress (exception can be made for abstracts accepted in the last 12 months for meetings other than EAU, ESTRO, EANM and ESR meetings).

Topics

EMUC topics consist of prostate cancer, urothelial cancer, renal cell carcinoma, testicular cancer, penile cancer topics or imaging topics. In case your abstract does not fall under any specific cancer type, you can submit your abstract under "Non-disease specific". For the full topic list, kindly see [this page](#).

Please note that abstracts submitted under one of the imaging topics will be discussed during the programme of the EAU Section on Urological Imaging (ESUI) in case of acceptance.

System requirements

We recommend using Google Chrome (latest version) for the best experience.

Size

The size of the abstract is limited to 3,000 characters (this includes title, body of abstract, spaces, tables and images). The submission programme will automatically calculate the size of your abstract and will not allow submissions that do not fit in the size requirements.

Every image counts for 500 characters and only jpg files can be uploaded (no pdf or other files).

For readability you are advised to make tables with the "insert table" tool and not upload this as an image.

Authors

Provide the full last and first names of all authors, omitting any titles, degrees and institutional affiliations. Please check that for authors from the same institution the name of the institution is written in the exact same way to avoid the creation of extra affiliations, which are in fact identical.

During the upload procedure, you can indicate who the presenting author will be, and this information can also be edited afterwards.

It is allowed that a non-author will be presenting the abstract.

It is allowed that an industry-affiliate will be presenting the abstract.

A maximum of 24 authors per abstract is allowed.

Each quoted author should have contributed substantially to the represented work in terms of conceptual design or analysis, writing of the article and final approval of the article in order to take public responsibility for the content.

Affiliation

Type the name of the institution, department, city and country. If co-authors are from the same institution, the programme will automatically copy all information into the next boxes, so that you do not have to retype all information. If co-authors are not from the same institution you can edit each box accordingly. Please make sure that the institution, department and city are written in English. The system allows authors to have only one affiliation, so in case someone works in different institutions, please indicate the main work place.

Title

- The title should clearly define the topic.
- There is no maximum length for the title, but the characters in the title are included in your total character count.
- The first letter of the title will automatically begin with a capital letter.
- Standard abbreviations may be used as follows: On first use spell out the full term and follow with the abbreviation in parentheses.
- Do NOT identify your institution in the title.
- Do NOT type the abstract title in capital letters.
- Do NOT end the title with a period.

Body of the abstract

State the objective of the study, describe the material and methods, summarize the results presenting sufficient details to support the conclusions reached (it is not acceptable to state: "The results will be discussed"). Use numbers to indicate values (i.e. "6" instead of "six") and only very well known abbreviations e.g., ml, kg, MRI... If you must use other abbreviations, you must explain the first time it appears.

The following headings have already been formatted for you and should not be entered in the text fields again:

- Introduction & Objectives
- Materials & Methods
- Results
- Conclusions

Proof reading

After you have inserted all data for your abstract submission a preview will show on your screen. Please verify that your abstract submission is correct and read this preview carefully (including author information). Keep a print for your own records.

It is the responsibility of the submitting author to ensure the abstract is in perfect order with no errors in spelling or grammar, as revisions will not be accepted. Abstracts will not be corrected.

Editing

Abstract bodies will be published as submitted, except for a simple English spelling check. You will be able to edit the abstract until the submission deadline. After the submission deadline there is no possibility to edit the submission text anymore.

Trial in Progress abstracts

Feel free to submit trial in progress abstracts, as these are allowed by the EMUC Congress office. The trial needs to be ongoing, i.e.: the first patient should already be recruited.

Encore abstracts

Encore abstracts are only accepted if the data significantly changed; e.g. larger patient database.

AI technology

Where authors use generative AI and AI-assisted technologies in the writing process, these technologies should only be used to improve readability and language of the work. Applying the

technology should be done with human oversight and control and authors should carefully review and edit the result, because AI can generate authoritative-sounding output that can be incorrect, incomplete or biased. The authors are ultimately responsible and accountable for the contents of the work. Authors should disclose in their abstract the use of AI and AI-assisted technologies. Authors should not list AI and AI-assisted technologies as an author or co-author, nor cite AI as an author. Authorship implies responsibilities and tasks that can only be attributed to and performed by humans. Authors are also responsible for ensuring that the work is original.

Human experimentation

Any human experimentation that has been conducted with respect to the submitted abstract(s), should have been conducted according to the protocol approved by the institutional or local committee on ethics in human investigation; or, if no such committee exists, the works should have been conducted in accordance with the principles of the Declaration of Helsinki of World Medical Association

Submission deadline

Deadline for abstract submission is 1 August 2026, 23:59:59 CEST.

To avoid that your abstract cannot be submitted due to technical difficulties, computer problems or other reasons, you are advised to submit your abstract on time.

Notification

The abstracts will be anonymously reviewed and sessions are composed. The outcome of the abstract selection is available online through this abstract submission website. You will receive a notification by e-mail indicating the exact date.

Cancellation, withdrawal or name changes

Cancellation, withdrawal or name changes should be notified 2 months prior to the congress by e-mail to emuc@congressconsultants.com

Publication

The accepted abstracts of EMUC are going to be published online in the EMUC resource centre, in the EMUC app and as an online supplement by Elsevier on European Urology Open Science. If you do not want your abstract published online please send an e-mail to emuc@congressconsultants.com.

Registration

It is mandatory to be [registered](#) for the congress. Abstract presenters are entitled to the early registration fee. Once the abstract outcome is known, you will be able to notify us on the presenting author via the system, and the system will automatically calculate the early registration fee for this person.

Copyright

- Copyright of the accepted abstract(s) is assigned to the EMUC Congress Office and any conflicts with any other scientific association will be the sole responsibility of the author(s).
- All published abstracts, including figures and tables, are the property of EMUC and are protected by copyright.
- By submitting an abstract you agree (also on behalf of co-authors) to the terms of use and conditions as stated above. Please note that transfer of copyright to EMUC applies to all materials derived from the abstract submitted (such as posters, videos, slide/audio presentations, live-streams, webcasts and all other materials).
- Copyright can be shared with companies for a maximum duration of 1 year, these requests have to be made written to sales@congressconsultants.com and come with a cost.

Display

All accepted abstracts will be on display as printed poster during the next EMUC edition. Among the accepted abstracts, several abstracts will be selected as best abstract and invited for oral

presentation and awards during the scientific programme.
